1. Apologies for Absence

Apologies were received from: Brian Porteous, Gillian Godfree, Brad Connor, Jan and Gareth Bryan-Jones, Chris Smithard, Jenny Hammond, Janine and Jason Inman, Donald and Lucile MacLeod.

2. Approval of Minutes of the 2021 AGM

Jen Leonard proposed that the minutes of the 2021 AGM were a true representation of the meeting. This was seconded by Neil Polwart.

3. President's Report

Jon presented his report of the year, the full text of which is appended to these minutes. FVO has staged lots of events at all levels during 2021, including at least one brand-new event – the Stirling City Race which is expected to become an annual fixture. Jon congratulated not only all medal-winners within FVO, but also those members who helped to stage events. In terms of the Club Development Officer role, Jon thanked Chris Smithard for his continuing support on the Committee and reported that Kieran Watts has made a great start in the role, with much to look forward to in 2022. Jon also thanked Roger Goddard for preparing the Strategic Plan progress report, which will act as a great guide going forward and has already highlighted a few areas for improvement.

Cathy Tilbrook thanked Jon and the Committee for a clear report, and these thanks were echoed by Brian Bullen and Jen Leonard. Jen also asked Jon what he saw as the biggest challenge; Jon thought this was communication to members at all levels – communication has been a bit last-minute recently, but this should settle down in 2022. Jen also noted that it was hard to keep up with bigger, non-FVO events that members may be interested in; Jon suggested we need to find a way to make sure everyone knows where to look for the appropriate information.

In closing, Jon commented that 2022 will be full and busy, more like a 'normal' year. There will be lots of opportunities to run for and help FVO – please sign up!

4. <u>Treasurer's Report</u>

Andy presented the Treasurer's report for the year, which is appended to these minutes. 2021 was a tricky year for financial planning and we stumbled through without the ability to plan ahead given the changing Covid landscape. End-of-year surplus was approximately £2,000, driven from local events, plus a gap in CDO funding. Income has roughly doubled from 2020 to 2021 – approximately £2,000 due to an accounting change, but mainly due to organising lots of events. Expenditure also doubled due to the increased number of events. CDO expenditure was less than in 2020 but expected to be approx. £10k going forward, with a lot of this covered by grants. Club net assets, after excluding allocated funds, stand at approx. £12k. Grants received during 2021 total approx. £16k – thanks largely to the efforts of Chris Smithard and Graham Gristwood in obtaining these. Andy also offered his thanks to the various funding bodies and to Simon Hunt for his advice and examination of the accounts.

Rona Molloy asked about athlete support; Andy replied that no support had been requested so none had been given. Neil Polwart asked if the event income was net of the credit card fees that are charged when using the online booking system; Andy responded that they were – which was good for comparison with previous years. Simon Hunt commented that the accounts were well maintained and easy to review, and congratulated both Andy and Dawn Goddard before him. Will Hensman asked if the 2022 spending for equipment and SI had been committed yet; Andy responded that the budget for 2022 was not yet decided but that he expected to be spending on SI kit. Cathy Tilbrook commented that assets of £12k represent a healthy balance, but is it so large that it can jeopardise future grant applications. Andy responded that assets have historically been in excess of £5k but that £10k is more appropriate now that we have more members. He noted we do need to ensure we are drawing down funds quickly enough to avoid creating problems, but that expenditure on mapping has been problematic during lockdown. Simon also added that £12k is roughly 6 months expenditure for FVO and we should be aiming to keep assets of 3-6 months, which is normal practice in the charity sector.

Jon detailed the events that are coming up next. First is an Explore activity tomorrow in Callendar thanks to Nicola, Kieran, Vicky and Heather. There is also an activity coming in mid-February in West Lothian; Jon thanked everyone who is working with Kieran to get this going.

Forth Valley Orienteers, 2021 Annual Report and Accounts

1. Presidents Report

1.1. 2021 – Still not a 'normal' year!

Last year's President's report by Jen Leonard began with the words "it's been an 'interesting' year to become president, but Forth Valley Orienteers shone through as an outstanding club yet again". Those words seem very apt this time too as I report on my first year as President!



We have had a full and busy year, despite the challenges of Covid that meant we were unable to hold our first event of 2021 until 28 March. We were in fact one of the first clubs in the UK to restart orienteering in 2021, and we were quickly into the swing of weekly events. Many other clubs were much slower to get going, and in fact British Orienteering contacted me to thank us for the example we were setting in terms of showing what was possible! It has been great to see so many people at our events, as well as so many of you getting involved in staging events or helping the club in other ways. Thank you all!

Your new committee took on the new Strategic Plan as agreed at the AGM, and this has been a great help for us in keeping track of goals and progress through the year. Thanks also to Jen who stayed involved to with an in-flight aspect of the Plan, and ensured that in May we were successful in our application for Scottish Orienteering Silver accreditation status.

You can see a summary in Appendix 5 which show the agreed targets under the Strategic Plan, and the progress against them. Given we were unable to stage events during the first quarter of the year, and continued to experience various challenges and restrictions (for instance with permissions), I am really pleased with how this year has gone. We are understandably short of some of the targets associated with total events and total participation, but nonetheless it is fantastic to have seen significant growth in club membership (to c250 members, see Appendix 4 for more detail). I think this is a great credit to the programme of local events and coaching, and many thanks to all of you who have been instrumental in putting those on and in being friendly faces offering support and encouragement to newcomers! Particular mention to Dawn Goddard for leading the weekly stretching and circuits class (ably assisted by circuits guru Roger) – it won't be long before this has been operating for two years as a weekly online training session!

We also agreed at last year's AGM to continue with a Development Officer role, and to extend that role to be 2 days/week. We were really pleased to be able to recruit Kieran Watts into this role to start in September, and he has wasted no time in getting involved. Kieran is already working to bring in new members as well as to provide support suitable for existing club members and volunteers of all ages and standards. His role is important to the success of the Strategic Plan and it is very positive to have him in place and already so active as we head into 2022. We were also very

fortunate in October 2021 to benefit from a full training week in FVO-land, with sessions from GB Team Lead Coach (and FVO member) Mark Nixon, and guest expertise from Swiss coach Coni Mueller who was on a sabbatical from work and generously offered a week of her time to coach us.

The growth in club membership - and the large number of events we now stage — are both only possible because of the number of club members who contribute their time, energy, and expertise. In Appendices 2 and 3 you can get some idea of the range of people who have helped with events and/or hold particular posts within the club. There are of course other contributions not fully recognised there — thanks so much to each of you for the role you play in making the club so active and so vibrant.

It was also very pleasing to be able to hold our Awards Evening as an in-person event this year. I recognise that not everyone was yet ready to come to an indoor event of that size, and I am sure we all very much hope that the 2022 evening will be able to go ahead without those concerns being such a factor. As ever with FVO, there was much individual and team success to recognise at the Awards Evening, for achievements at all of local, national and international level. Some of the headline successes are reflected in Appendix 1 but in many ways this just scratches the surface — well done all! From a team perspective the highlights were at the Compass Sport Cup Final and at the British and Scottish Relay Championships that we staged in Loch Ard Forest. We put up a very strong defence of our Compass Sport Cup title, narrowly beaten by the host club South Yorkshire but with the second highest score ever by a losing team, a great effort! In the Relay Championships, we took the British and Scottish Men's Open title (the Scottish one for the first time that I can remember!), as well as the Scottish junior (MW44-) title.



As well as all of our local and newcomer events, we (as above) hosted the British and Scottish Relays, with the inaugural Stirling City Race the next day. And this year's Scottish 6-Day event saw a different format of 3 days per competitor, but we as usual staged a day, this time at Creag Dubh near Newtonmore. We had the usual huge attendance from FVO members at the 6-Day, and the usual fun run-in competition! (Congratulations to Jamie Goddard who won that and then went on to win the Golden Boot at the Compass Sport Cup Final too).

Apart from the restrictions that have applied at various times during the year, our main problem for organising orienteering events through the pandemic has been getting permission from landowners. When we have got permission, it has often been at very short notice due to the regular changes in Covid guidance. I realise this has meant some events (and some online entry) have only been advertised at short notice too – thanks for bearing with it!

1.2. Looking Forward

The year ahead looks exciting, with the British and Scottish calendar looking much more normal, with a full calendar of championship (and other favourite) events. And as you would expect, FVO has many plans too! We intend to field teams at all the major relays, with high hopes for many of our teams. And of course we have a Compass Sport Cup to try and win back!

And talking of the Compass Sport Cup...we are hosting the final, in October at Tulliallan and Devilla near Kincardine. This is our most major event of the year (as well as being a great chance to field a strong team), so please put it in your diaries to come along and help. It will be a double-header weekend, with the second Stirling City Race the day before.

We are also delighted to be making strides with our 'Callander Hub' activities, using the new maps that we received grant funding to produce. This also means we have a brand new map of Callander Crags, mapped for orienteering for the first time. We are using that for the Scottish qualifier round of the Compass Sport Cup in March, again as part of a double-header weekend, with a middle race at Falkirk Wheel the next day.




Our other major event scheduled for 2022 is the Harvester Relay, the only night-day relay on the UK calendar. We have been trying to stage this since 2020 and it remains a challenge, not least as our planned location (Drumlanrig Castle) has been heavily affected by Storm Arwen. We continue to work on it, with a planned date of 13-14 August.

All this – and of course our normal full programme of training, club activities and a range of local events alongside our night, sprint, and Wednesday evening series! We will continue to focus on offering suitable opportunities for all club members, as well as continuing to pursue the key goals and aspects of the Strategic Plan. And of course we want to encourage everyone to enjoy their sport, to represent our club when they can, and to be inspired by the performances of our top athletes as they seek international success!

2 Treasurers Report

2.1. Overview



2021 was a transitional year financially for the club, with a significant increase in club activities leading to much higher income and expenses. Despite the club not being able to stage any events for part of the year and major events for most of the year, the club recorded a surplus of c£1.9k. This surplus was driven by healthy attendance at local events and a period during the summer when costs were not incurred for the Development Officer position.

The club has been successfully awarded £8.6k of grants over 2021, which will go towards expanding our mapping programme and expanding the development officer position to two days a week.

The club's bank balance stands at c£29k as of 31 December 2021. Approximately £16k of this balance is ring fenced as "Deferred Grants" which will be drawn down over the next few years as we fulfil the plans outlined in each grant application. This leaves "net assets" of c£12k (c£29k less c£16k) at 31 December 2021. Having a solid balance sheet stands the club in good stead for the short term as the Club Development Officer role has now expanded to 2 days a week to form a larger portion of fixed costs, and the club looks to put on, and partake in, major competitions.

2.2. Income

The table below shows the income for the period to 31 December 2021. Commentary follows the table and more detailed notes referenced in the last column are included in the later sub-section "Notes to the Accounts".

The significant increase in income in 2021 compared to 2020 is driven by a combination of increased club activities as Covid restrictions eased and a change in accounting approach. The 2021 accounts have now been refined to segregate the event income (i.e. entry fees) from the event expenses (levies, printing costs etc); in 2020 these items were netted and presented as a single line "net income" line. In 2020 the equivalent total event income was £4,035 vs £12,454 in 2021.

Covid restrictions limited the ability of the club in 2021 to put on larger events which typically generate a significant surplus to fund our development objectives. Nonetheless, it was great to see the club host the British Open Relays and Stirling City Race, which was a financial success (as well as

a logistical and athletic success). Attendance at local events was significantly higher in 2021, driven by more events and more people at each event.

The Club Development Officer ("CDO") position was expanded to 2 days a week in 2021. The Direct Club Investment ("DCI") funding finished at the end of 2020, and the cost of the CDO is now borne by FVO, supported by a number of successful grant applications.

2.3. Expenditure

The table below shows the expenditure for the period to 31 December 2021.

Expenses were c£10k higher in 2021 than 2020. Again, the significant increase is due to an increase in club activities across the board and the accounting change to segregate event expenses as shown above.

Our largest expense going forward will likely be the Development Officer who is now working c2 days per week. The Development Officer expenses are lower in 2021 as Kieran started the role in the last third of 2021.

Mapping costs continue to be a large area of spend as the club invests in expanding the suite of mapping into new areas, whilst ensuring the catalogue of maps are well maintained. Where possible grant funding is sought to cover these costs. Budgets are set and reviewed at each Committee meeting when appropriate.

An order of club kit was placed over the year and involved a lot of learning about post-Brexit EU import rules (well done to the Hammonds)! FVO has subsidised c15% of the total cost on average.

The reduced number of competitions meant that lower subsidies were paid to members compared to Pre-Covid years.

The main equipment purchases in 2021 related to a new battery back allowing our local events to support live results processing.

2.4. Income Less Expenditure

Overall, a net surplus of c£1.9k arose in 2021, compared to a c£0.6k deficit in 2020. A small surplus in 2021 is considered a positive outcome in the context of the year and positions the club well for 2022 when the expenses associated with the Development Officer position will ramp up.

The club may appear to have substantial cash reserves, but the majority of the funds are ring fenced for specific purposes as outlined in our grant applications.

In addition to the recognised assets and liabilities mentioned above, FVO also has the following non-capitalised assets:

Equipment (SI and Other) – which has been expensed through the Income and Expenditure Account as this equipment was purchased The SI equipment is expensive to replace and is difficult to insure. Other equipment was recently valued at c£15k replacement cost.


2.6. Grants

The club has been highly successful at securing grants over 2021, with a total of £8.6k grants being awarded:

- £6,000 from the National Lottery Awards for all to support expansion of mapping and the expansion of the development officer role.
- £2,000 from the Orienteering Foundation to support the increase in the Development Officer position to 2 days per week (further funding in future years is expected based on satisfactory progress).
- £600 from Dunblane Development Trust to establish new permanent orienteering courses.

Many thanks are due to all those grantors who have provided funds and Graham Gristwood (mapping officer) and Chris Smithard (outgoing Development Officer) for co-ordinating and completing many of the applications.

The table below shows a detailed breakdown. Grants are recognised as income only when the underlying costs associated with that grant are expensed. Many of the grants will therefore be recognised gradually in the income of the club over next 1-2 years. This approach avoids large unrepresentative swings of surplus and deficit in the accounts when grants are initially awarded. "Deferred grants" represent grants awarded where the underlying expenses are still to be incurred.

2.9. Accounting Policies

The Accounts have been prepared on an accruals basis, so income and costs are included in the Income and Expenditure Account in the year to which they relate.

Unsold kit stock, unused grants, and other balances due to and from external parties, are included as Assets and Liabilities of the Club.

2.10. Notes to the Accounts

Note 1: Membership

A refinement has been made in 2021 to account for membership fees on an accruals basis (as opposed to cash basis). This has been done approximately using the date of payment of membership to determine whether that membership relates to the current calendar year or the next one. This change in approach has led to a slight step down in the disclosed 2021 Membership income. Membership renewals for calendar year 2022 received in November & December 2021 have now been deferred to next years 2022 accounts, whereas previously they would have been recorded in the 2021 year.

Note 3: Event Income

Breakdown of the event income and expenses is shown below. Despite some Covid restrictions in 2021, the events generated a healthy amount of surplus.

Note 4: Scottish Six Days Income

Historically, a proportion of the income generated from the Scottish Six Days in 2019 is allocated to the various Scottish orienteering clubs based on the roles that club members fulfil. No distributions to Scottish Clubs were made following the Scottish Six Days in 2021 given the more challenging financial conditions. FVO does not budget for this income as a matter of course.

Note 5: Socials

Socials are expected to be broadly cost neutral. A small surplus for Kincraig is largely due to a £250 deposit for the weekend being recognised in a prior year.

Note 6: Net cost (surplus) on Sale of FVO Clothing

Note 7: Development Officer

Over the year Kieran Watts was appointed as our part Club Development Officer (CDO), who works on a self-employed basis around 2 days per week.

In 2021, the club received c£7k that was held by SOA in relation to the historical operation of the CDO position from 2015 – 2020. FVO had paid a fixed amount to cover the salary, expenses, pension amounts for the CDO, plus an administration charge. This fixed sum was approximate and slightly prudent which led to a surplus balance at SOA, which has now been returned to FVO, where it will be deployed for development purposes.

Note 8: Mapping Costs

Table below shows a breakdown of the c£7k mapping spend. The majority of total expenditure was matched with grants during the year.
